

## **SPECIAL CALL MEETING FEBRUARY 4, 2013**

Be it remembered that the Mayor and Board of Aldermen of the City of Ocean Springs met in a Special Call Meeting at City Hall in the City of Ocean Springs at 5:00 p.m. on February 4, 2013. Mayor Moran presiding, Aldermen Cox, Gill, McDonnell, Cody, Denyer, Dalgo and Hagan were present. Also present was City Clerk Shelly Ferguson and City Attorney John Edwards.

The Mayor called the meeting to order.

The Special Call Meeting is for the purpose of any and all matters pertaining to interviews for School Board Commissioner and Civil Service Commissioner.

The Mayor and Board of Aldermen interviewed the following candidates: Sharon Walker, Lisa Chapman, Todd Coulter, Julie Cwilka, Anthony Herbert, Frances "Sue" White, Joanna Worch, Jaklyn Wrigley and Mia James for School Board Commissioner.

Alderman Denyer recused himself from the interview of Sharon Walker.

The Mayor and Board of Aldermen interviewed Mia James and James "J.D." Reeves for Civil Service Commissioner.

Motion was made by Alderman Cody, seconded by Alderman Gill and unanimously carried to appoint James "J.D." Reeves to the Civil Service Commission.

Following the interview process, the Board of Aldermen ranked the candidates. The top three (3) candidates were Anthony Herbert, Frances "Sue" White and Jaklyn Wrigley.

Motion was made by Alderman Gill and seconded by Alderman Hagan to appoint Jaklyn Wrigley to the Ocean Springs School Board. After further discussion Alderman Gill withdraws his motion and Alderman Hagan withdraws his second to the motion.

Motion was made by Alderman Hagan and seconded by Alderman Dalgo to appoint Anthony Herbert to the Ocean Springs School Board. Motion failed with Aldermen Dalgo and Hagan voting aye and Aldermen Cox, Gill, McDonnell and Dalgo voting nay. Alderman Denyer recused himself from the vote.

Motion was made by Alderman McDonnell and seconded by Alderman Cody to appoint Frances "Sue" White to the Ocean Springs School Board. Motion was tied with Aldermen McDonnell, Cody and Cox voting aye and Aldermen Gill, Dalgo and Hagan voting nay. Alderman Denyer recused himself from the vote. Mayor broke the tie. Motion failed.

Motion was made by Alderman Gill and seconded by Alderman Dalgo to appoint Jaklyn Wrigley to the Ocean Springs School Board. Motion failed with Aldermen Gill and Dalgo voting aye and Aldermen Cox, McDonnell, Cody and Hagan voting nay. Alderman Denyer recused himself from the vote.

Motion was made by Alderman Hagan and seconded by Alderman Dalgo to appoint Anthony Herbert to the Ocean Springs School Board. Motion failed with Aldermen Dalgo and Hagan voting aye and Aldermen Cox, Gill, McDonnell and Dalgo voting nay. Alderman Denyer recused himself from the vote.

Motion was made by Alderman Cox, seconded by Alderman Cody and unanimously carried to appoint Frances "Sue" White to the Ocean Springs School Board. Alderman Denyer recused himself from the vote.

Motion was made by Alderman Dalgo, seconded by Alderman Gill and unanimously carried to adjourn the special call meeting.




