

SPECIAL CALL MEETING OCTOBER 14, 2014

Be it remembered that the Mayor and Board of Aldermen of the City of Ocean Springs met in a Special Call Meeting at City Hall in the City of Ocean Springs at 5:30 p.m. on October 14, 2014. The *Mayor Pro Tem* Gill presiding, Aldermen McDonnell, Cody, Denyer, Dalgo and Impey were present. Also present was Deputy City Clerk Karen Kennedy. The Mayor was absent and Alderman Cox was absent during roll call but arrived later in the meeting.

The *Mayor Pro Tem* called the meeting to order.

The Special Call Meeting is for the purpose of any and all matters pertaining to authorizing to advertise the Government Street Improvements Project pending MDOT authorization, MDOT STP funded project (A-1a); approving the Special Event Permit Application for the Fear Fete Zombie Pub Crawl on Saturday, October 18, 2014 from 8:00 p.m. to 10:00 p.m. (Exhibit A-1b); and discussion concerning Peter Anderson Festival and road closures with action to be taken on the Special Event Permit Application.

Motion was made by Alderman Denyer, seconded by Alderman Dalgo and unanimously carried to authorize the advertise the Government Street Improvements Project pending MDOT authorization, MDOT STP funded project (Exhibit A-1a).

Mayor Pro Tem Gill stated he along with Alderman Cody, Capt. Hoppner, Fire Chief and Assistant Public Works Director met with the organizers of the Fear Fete Zombie Pub Crawl. This event is scheduled for Saturday, October 18th from 8:00 p.m. until 10:00 p.m. The Mayor Pro Tem pointed out that this event is scheduled for the same night as the 5K Rotary Run which begins at 6:15 p.m. After much discussion, the committee recommends approving this Special Event Permit Application due to the Zombie Pub Crawl not beginning until 8:00 p.m. and the Rotary run for the adults beginning at 7:00 p.m.

Alderman Cox arrives at the meeting.

Alderman McDonnell asked if additional security will be brought in for this event. Capt. Hoppner said no additional security will be needed. Alderman McDonnell asked to have two (2) additional officers on segways to patrol the side streets. The organizers of the Zombie Pub Crawl agreed to pay for these two (2) additional officers. Parking issues were also discussed and recommended to direct overflow traffic to the parking lot at Public Works near the armory.

Motion was made by Alderman McDonnell, seconded by Alderman Cox and unanimously carried to approve the Special Event Permit Application for the Fear Fete Zombie Pub

Crawl for Saturday, October 18, 2014, from 8:00 p.m. until 10:00 p.m., pending payment of \$150.00 for additional security (Exhibit A-1b).

Alderman Cody presented the Special Event Permit Application for the Peter Anderson Festival scheduled for November 1st and 2nd.

He asked to have a meeting with Alderman McDonnell, Capt. Hoppner, and Deputy City Clerk to review and finalize the road closures for this event along with the Fire Department and Public Works Department.

Motion was made by Alderman Denyer, seconded by Alderman Dalgo and unanimously carried to appoint Alderman Gill, Alderman Cody, Capt. Hoppner and Deputy City Clerk to a committee to establish road closures for the Peter Anderson festival.

Alderman Denyer asked for more signage to direct vehicles with boats to use Porter Avenue to Dewey Avenue. Alderman McDonnell asked that the residents and businesses be provided with letters of explanation along with a parking decal for their windshields as to the ingress and egress during the event.

Motion was made by Alderman Cody, seconded by Alderman McDonnell and unanimously carried to approve the Special Event Permit Application for the Peter Anderson Festival 2014, pending the final map approval and completion of the application to be resubmitted at the next board meeting (Exhibit A-1c)

Alderman Impey asked that the application be sent back to the Chamber of Commerce to be properly completed and resubmitted at the next Board meeting. Alderman Cody will assist the Chamber of Commerce in completing the application.

Motion was made by Alderman Denyer, seconded by Alderman Cody and unanimously carried to adjourn the Special Call Meeting.




