

SPECIAL CALL MEETING AUGUST 28, 2021

Be it remembered that the Mayor and Board of Aldermen of the City of Ocean Springs met in a Special Call Meeting at the EOC – Emergency Operations Center in the City of Ocean Springs at 8:00 a.m. on August 28, 2021. The Mayor presiding, Aldermen Burgess, Authement, Wade, Cox, Papania, Blackman, and Impey were present. Also present were Fire Chief Derek McCoy, City Clerk Patty Gaston, Deputy City Clerk Vicky Hupe, Police Lieutenant Brian Kestner, Human Resources & Risk Management Director Mindy McDowell, Public Works Assistant Director Candice Hooks, Parks & Recreation Director Stephen Glorioso, and Parks & Recreation Assistant Director Chris Kostmayer. Brooks McKay, Director of Operations with the Ocean Springs School District, also joined the meeting.

The Mayor called the meeting to order.

The Special Call Meeting is for the discussion of all matters pertaining to:

- a) Discussion of Hurricane Ida

A motion was made by Alderman Impey, seconded by Alderman Cox, and unanimously carried to accept the agenda.

The Fire Chief said Ocean Springs is currently under a Hurricane Watch and a Tropical Storm Warning. He said landfall is expected to be in Morgan City, Louisiana Sunday night as a Category 4 with 140 m.p.h. winds. He said Tropical Storm winds are expected in Ocean Springs midday Sunday with 6 - 7 inches of rain and 4 – 11 feet of storm surge. He said the Fire Department will have a few extra staff on-site similar to Hurricane Zeta preparations.

The Police Department, Public Works Department, Parks & Recreation Department, and the City Clerk discussed their preparations and plans for clean up after the storm.

Mr. McKay said Ocean Springs schools have been canceled for Monday with plans to reopen Tuesday after the county clears all of the bridges the busses must cross.


The City Clerk said pictures are needed of the current Hurricane Zeta projects before the storm.
