[Redacted] stated the vendor got in her face aggressively and was intimidating her threatening to fight her.

On the 2nd day of December, 2022, at approximately 2225 hrs. I observed a Chevy Silverado traveling westbound on Government Street near Twisted Anchor Tattoo. The vehicle suddenly drifted towards the north side of the road and struck a Honda Accord on the drivers side. The truck struck the other vehicle so hard that the front passenger side of the truck jumped off of the ground. As I was passing the truck, I could hear the engine begin to rev up as though it was no longer in gear. I turned on my blue lights and began to turn around.

At that point, the truck began to drive away slowly. I followed behind the suspect vehicle and it came to a stop in front of the Scratch Kitchen. The vehicle was a 2012 Chevy Silverado displaying [Redacted]. The driver immediately got out of the vehicle and began stumbling to the front of his truck. I stepped and commanded the driver to come to the back of his vehicle to speak with me. He was unable to understand me and kept looking at the front of his truck. I again commanded him to walk to me, at that point he began to walk my direction. He then walked toward the front of his vehicle on the passenger side. I shouted at him again to come back to me. He again walked back to me.

I asked him what he was doing and he did not rationalize that he had hit another vehicle. I explained to the driver that he had hit another vehicle and tried to drive away. He explained that he had stopped and I explained that he hit another vehicle and attempted to drive away until I put my blue lights on and he then decided to stop. I asked the driver for his license and insurance. He provided me with a MSDL which helped me identify him as [Redacted]. After [Redacted] gave me his drivers license, he again walked toward the front of his vehicle on the passenger side.

I shouted for him to walk to the rear of his vehicle again and he did not respond. At that point, I walked toward [Redacted] and explained that if he disobeyed a direct order one more time, I was going to take him to jail. He acknowledged me and walked to the rear of his vehicle again. He stated he would sit on his vehicle and I told him multiple times that I did not want him to sit, I wanted him to stand. He made it to the rear of his vehicle and sat on the back of his truck anyways. I again told him to stand up and he slowly cooperated.

I asked [Redacted] what caused him to hit the other vehicle and he stated that he looked at his phone. I asked him if his drivers license had the correct address on it and he stated it did not. He then told me his current address. He struggled when trying to give me street name for his new address. He began apologizing and I asked him where he was coming from. He repeated my question and then stated he was coming from right up the road. I signaled for him to elaborate further and he attempted to tell me the "Salty Peach Bar." His speech was very slurred when he was saying "Salty Peach" so he had to repeat himself three times before I was able to understand what he was saying.

I asked him how much he had to drink at the Salty Peach and he said he had not drank

very much there. I told him that it was obvious he was highly intoxicated and then asked where he had consumed the majority of the beverages at. He explained that he had drank "a little", I asked him if he had drank a little or a little too much. He agreed and stated he had drank too much. As I had been speaking to him, I could see his eyes were glazed, his speech was slightly slurred and he was swaying back and forth. I advised him that I was charging him with DUI and secured him in double-locked handcuffs. I searched his person prior to handing him over to another officer to assist with transporting him to OSPD.

I performed a vehicle tow inventory prior to contacting A Towing. A Towing responded to the scene and took possession of the vehicle. I went back to Ocean Springs Police Department to assist in processing [Redacted]. I was unable to offer Duke the opportunity to provide a breath sample to the Intoxilyzer 8000 due to the machine not accepting my card. I noticed during the booking process, Duke repeated himself several times and struggled to answer basic questions when asked. He asked several times where his phone was located and was told several times it had been left in his vehicle.

When I attempted to fingerprint [Redacted] he was swaying so much it made it very difficult to fingerprint him. He continued to apologize for what he had done and kept stating that he knew he had "fucked up." We allowed him to contact his mother and he admitted to her that he never drives when he is like that and that he had made a big mistake. After he was finished being booked, he was transported to the Jackson County Adult Detention Center. [Redacted] was charged with DUI 1st and issued a traffic citation for careless driving.

Officer Doughty, Officer Nguyen and myself were walking near the intersection of Cash Alley and Desoto talking when we heard one single gunshot. I unholstered my duty weapon and ran towards where the shooting had occurred. I observed crowds of people running frantically away from the scene. As I continued West on Desoto towards The Scratch Kitchen, I observed a black male hopping on one leg in the middle of the street. I observed the black male identified as Redacted bleeding from his right leg. Officer Nguyen assisted the black male out of street and to a place to provided medical attention. I noticed Redacted jump and discard something over a wooden fence that he was standing against. I heard whatever he threw over the fence hit the concrete. I acted like I didn't see anything at that time until we could get the chaos under control.

I yelled to Officer Nguyen to put a Tourniquet on Redacted. I provided a tourniquet for Officer Nguyen to use on Redacted and held security for Officer Nguyen while he provided medical care. I looked behind the fence with my flashlight to see if I could see what was thrown on the other side. I observed a black handgun with blood all over it sitting on the other side of the fence. Sgt. Meadows approached me and I informed him on my findings. We came up with a plan to just leave the gun there until we were able to safely collect the firearm. During this time, crowds continued to form where we were providing care for Redacted. Lt. Carroll advised dispatch to call in different agencies for crowd and traffic control. The crowd eventually dispersed. Acadian and Fire arrived on scene and helped get Redacted to the ambulance.

Once everything calmed down, Sgt. Meadows and I proceeded to collect the firearm that Redacted had thrown over the fence. Pictures were taken of the firearm as it laid on the ground from Redacted tossing it over. I also took pictures of the scene and the fence that the gun was behind to get a better picture of the layout of the scene. After taking necessary photos of the firearm, I grabbed the firearm and secured it. While I had the firearm in my hands, I could feel the barrel of the pistol being warm, as if it had just been recently fired. The firearm was covered in what I assumed was Redacted blood. Sgt. Meadows took possession of the firearm and placed it into the back of his patrol unit #2106 until Det. Bourque was able to take possession of it. Lt. Carroll and Officer Walker had taken possession of a firearm off a black male during a separate incident. Lt. Carroll had asked me to run the Serial number through dispatch. It was a Glock 19 firearm with serial number Redacted. The gun came back negative in NCIC. The firearm was placed in the trunk of the male's Dodge Charger.

Officers heard the sound of screams coming from the parking lot West of the Scratch Kitchen. Officer Doughty and Myself ran to the area and observed NBN Agents trying to get individuals to leave the scene. I observed MBN Agent Saylor escorting an irate female in handcuffs. Agent Saylor asked if we had a marked unit available. We escorted a black female identified as Redacted.

On 4/16/2023 at 2110 hours, I, Officer Doughty, was patrolling the downtown area and came upon a large crowd on DeSoto Street for an event happening at The Scratch Kitchen (1013 Government Street). I was approached by multiple individuals and was informed of a fight happening. I informed dispatch of the situation. I observed multiple individuals in the street with vehicles unable to pass through. Officers McGill and Nguyen arrived to assist. We approached the crowd and it started to disperse.

We continued to monitor the crowd and attempted, multiple times, to keep them out of the street so that vehicles could pass through. At approximately 2116 hours, I was on foot at Cash Alley and DeSoto Street when I heard what sounded like a gunshot, west of my location near the crowd. Multiple individuals fled the area on foot and Officer McGill and I ran towards where the sound came from. I observed a male individual hopping on one leg west on DeSoto. Officer Nguyen and McGill made contact with him to assist with his injury. I observed approximately four black males jump into a white in color Jeep Wrangler with all four doors removed. They fled the scene west on DeSoto then turned north onto Cash Alley at a high rate of speed. I informed dispatch of the description and a partial **Redacted**

I heard more individuals screaming near the back entrance of The Scratch Kitchen and I was informed a woman was possibly having a seizure. I made contact with her and requested Acadian Ambulance Service be dispatched. She would later refuse medical treatment and an additional medical unit was cancelled. I made contact with the owner of Scratch Kitchen, Brittany Cruso, as she was attempting to leave the business. I asked her if her cameras work and she said they did but she can only access them on her phone. I told her she would need to stay until one of my supervisors could talk to her.

I redirected my attention to the crowd and attempted to get individuals to leave the scene so that Fire and Medical could get through to assist. Multiple outside agency units arrived and I asked them for assistance in crowd control and for some Officers to assist in locating a bullet casing near the parking lot north of Scratch Kitchen. Lt. Carroll also canvased the area and informed dispatch that we were unable to locate one at that time.

I made contact with the gunshot victim, who was receiving medical attention inside the Acadian Ambulance. He said his name was **Redacted**. I asked him what happened and he said he was walking (west) on DeSoto Street towards the Scratch Kitchen and a guy gave him a funny look. He said that he asked him what's up and the male pulled a gun out and shot him in the leg. I asked if he knew who the male was and he said he did not. I called his information into dispatch and he was taken by ambulance to the hospital.

As the area was starting to come under control, I heard a loud commotion in the parking lot just west of the Scratch Kitchen. Multiple individuals were running out saying "They're fighting!". I

On 04/16/2023, at approximately 2111 hours, Officers with the Ocean Springs Police Department were dispatched to the area of 1013 Government Street (The Scratch Kitchen) for a possible fight in progress. Upon officer arrival, It was found that the fight had ended. Officers then got word through dispatch that another fight was brewing inside of The Scratch Kitchen. While Officers were on scene and canvassing the area behind The Scratch Kitchen on Desoto Street, Officer heard one gun shot. At this point, a crowd of people started to run chaotically in an effort to exit the area. Officers found one black male, identified as **Redacted** limping with what appeared to be blood on his pants. Officers got the male behind the old Kwitsky's bar between a car and fence to shield him and to explore the area he was injured.

Upon my arrival, I noticed a crowd of people yelling and gathering around the area of the victim. I instructed officers to make sure they kept the bystanders back and to find out more information. I went to assess the extent of the injury to the victim that Officer Nguyen was attending too. The crowd around the area grew quickly and they were forced to back up. Officers called for medical assistance which arrived shortly after. I summoned for dispatch to send Jackson County units to my location to assist with traffic control. Once medical personnel and additional units arrived, I notified all proper in my chain of command of the events that were taking place. I instructed several officers to get any information that they could in order to help with the investigation or to help us find a suspect.

The crowds started to disperse with the assistance of MBN, FBI, OSPD, and Jackson County units. Officers canvassed the area for any evidence such as a shell casing or a weapon. Sgt. Meadows and Officer McGill found a small handgun in the area by the dumpster where the victim was being tended too. The firearm was confiscated and turned over to Detective Bourque. After all people were forced to leave the area, I found an employee that had contact information for someone that may have video footage of the incident. The video footage will be from the area behind The Richey Building. The information provided is listed below.

Officers were patrolling the in area of the Scratch Kitchen (1013 Government) in regards to a large crowd, parking complaints and possible physical alterations.

Sgt. Meadows arrived at the location, parking at Desoto/Cash Alley, heard a single shot discharged from a firearm and the crowd dispersed. Dispatch was informed to contact the Jackson County Sheriff's Department to request additional units to assist with the scene/crowd control.

Officer Tam Nguyen located an injured male and moved him to safety, behind a vehicle, in a nearby alleyway. With the assistance of Officer Derick McGill, they provided emergency medical care to the male. A tourniquet was applied to the upper right thigh of the male to stem the blood flow from his injury. Medical units were called to the scene.

As the scene was being secured and the male was being transported by medical personnel, the Criminal Investigations Division (CID) had been notified and arrived. Detective Parker Bourque was briefed on the incident and informed of possible evidence discovered.

As the male was being moved and cared for, Officer McGill observed/heard the male discard an item along the fence line. A firearm was later located, photographed, and collected as evidence.

The firearm was turned over to CID for processing and logging into evidence.

A possible suspect vehicle was seen fleeing the area, moments after the shot was fired. The vehicle was described as a white Jeep Wrangler, 4-door (doors removed). It was last seen traveling east on Desoto and turning north onto Cash Alley.

Assisting Agencies later located the vehicle and driver on Robinson, near Handy. An arrest was made with the driver being transported to the Jackson County Adult Detention Center. E&M Wrecker Service took possession of the vehicle from the scene.

I placed Redacted down to the ground and looked for the gunshot wound which I found it to be in his upper right leg area. Officer McGill covered me from behind and tossed me a tourniquet. On 4/16/2023 at approximately 2111 hours, I, Officer Walker #37, responded to The Scratch Kitchen (1013 Government St.) for a shots fired call on Desoto St. behind The Scratch Kitchen.

Upon arrival, I parked my vehicle on Government St. near Cash Ally and ran towards Desoto St. with Lieutenant Carroll who had also arrived on scene at the same time.

As I rounded the corner running, I noticed Officer McGill standing near a black Camero. They advised that a black male, later identified as **Redacted** had been placed behind the vehicle with a gunshot wound to his leg. I observed Officer Nguyen squatting towards the back driver side of the vehicle with the gunshot victim.

At that point a large crowd of individuals rushed to where I and other officers were. I advised the crowd to stand back from the vehicle. I stood near the rear of passenger side of the vehicle that was parked with its rear-end underneath a patio covering, to keep others from going near the victim.

While standing guard a black male in a blue shirt with blue jeans who advised he owned the Charger we were guarding, opened the passenger door and I reach to stop him and as he lifted his shirt to show me the keys on his waste, I noticed a 9mm Glock with an extended magazine tucked in his waste band. I yelled to LT Carroll and other officer to inform them the male had a weapon on him. I kept the males shirt lifted for clear view of the handgun tucked in his waste band and kept his other hand away from the fire arm as LT Carroll who was standing behind me at that time reached in between myself and the male and confiscated the firearm and placed it on the rear trunk of the vehicle where it was then unloaded. I push the male away from the vehicle in order to keep my vision on other people near the area to which I was standing.

I continued to stand watch of the area when I noticed Officer Nguyen helped the gunshot victim to stand up, walking him away and towards the Acadian Ambulance Service that had arrived on scene.

I was directed shortly after by LT Carroll to gather more information on the shooting from other parties however, no one that I had spoken to saw the incident occurred.

After speaking with multiple parties on scene, I spoke again with LT Carroll advising no one had seen the shooting occur and was then directed to speak with the owner of Scratch Kitchen, Brittany Alexander, to gather any possible camera footage of the incident.

While speaking with Mrs. Alexander, she advised she would have their personal IT team place all video footage from the night of the shooting on a flash drive and make contact with OSPD in the following days.

I stayed with the female as Officer Nguyen met with the mother, to bring her to the daughter. Once her mother was on scene, it was decided by fire officials on scene to place her on a back board and carry her to her mother's vehicle.

Officer Nguyen, myself, and two other fire officials placed the female on a back board and carried her from The Scratch Kitchen to her mothers vehicle parked near Tato-Nut Donut Shop (1114 Government St).

On May 5, 2023 at 2252 hours, I Officer Wanhala #45, responded to shoots fired at The Scratch Kitchen (1013 government Street). While responding Sgt Meadows #18 requested patrols to respond to Desoto street.

I responded by activating my emergency lights and sirens and responded running code to the Scratch Kitchen from Government Street Quick Stop (2340 government Street) then turned east onto Government Street, then north onto State Street and West onto Desoto Street. When approaching Scratch Kitchen there were numerous vehicles and personal in the street leaving the The Scratch Kitchen. When I exited my vehicle, I had personal grab me and tell me someone was injured inside the back patio of the restaurant. When entering the back patio Cpl Frazier #34 was also entering at the same time with me. Frazier and I saw the a black victim at the same time and Frazier initiated CPR with about three other people helping to do CPR on the victim. While Frazier was doing CPR I watched the area for any other victims or violent personal. While numerous people where crowding Frazier and myself. While scanning the area and telling people to move back I noticed a pistol on the ground next to the victim's right hand that was beside his shoulder and beside his head. I secured the pistol in my left hand. After I secured the pistol, Sgt Wallace #19 approached me after he entered from the front of the building and told me to clear the gun out and secure the weapon in my pocket. I cleared the weapon, and there was a round in the chamber. The pistol was secured in my right cargo pocket. The magazine and the round was secured in my left cargo pocket. After securing the weapon, Frazier asked me for a tourniquet and I supplied one to him, but that's when Frazier noticed the victim had only a chest wound and no other wounds on his extremities. More people started to rush Frazier and I that's when Frazier stated to me to cover his back. After a few seconds dealing with more people trying to come into the scene Officer Kirkland #48 arrived and also started to do CPR on the victim. While Frazier and I tried to push people back. While Kirkland was doing CPR, Acadian arrived on scene and pronounced the victim died.

Lt Kestner arrived and started to put up crime scene tape around the back patio. After cordoning the back patio off I went to my vehicle 1712 and put the pistol, magazine and the single round in brown evidence bag. I secured the bag on the floor board of my front passenger seat. After securing the evidence I helped make the crime scene larger on Desoto Street. Then after making the crime scene larger, I helped with crowd control in the front of The Scratch Kitchen on Government Street.

Detective McClellon #16 requested the pistol that I recovered and I handed off to Detective McClellon for processing.

Until about 0330 hours I stayed on government street conducting crowd control.

On May 6, 2023, at approximately 2242 hours, Officer Mammoser and I, (Sergeant Wallace) conducted a traffic stop off Bowen Avenue where the car final stopping location was at the First Baptist Church North parking lot. At approximately 2250 hours I heard what sounded to be approximately 5 consecutive gunshots coming from North of our location. I immediately used my portable radio to ask Sergeant Meadows who was working in the downtown area near Glory Bound (1107 Government Street) did he hear the sound that I heard. I received no Immediate response from Sergeant Meadows but at approximately 2251 hours Sergeant Meadows broadcasted over the radio that he had shots fired with multiple victims struck near The Scratch Kitchen and Bar (1017 Government Street). Officer Mammoser and I released the two men from detainment and started responded toward the area of Washington Avenue and Government Street.

Upon arrival, I observed multiple individuals running West towards our location, but none appeared to be injured by gunfire. I asked one black male wearing a white shirt, black pants, black hat, and black shoes standing on the corner of Washington Avenue and Government Street where did gunshots come from. The unidentified black male pointed East and said, "that way", I ran towards the area of 1017 Government Street where Officer Mammoser and I was told that the shooter was inside the building. I Immediately unholstered my duty weapon and took a low ready position on the West side of the entry door. I broadcasted over the radio about a possible suspect being inside the business and asked for emergency radio traffic. A staff member unlocked the door from the inside and we made entry to locate for a potential active shooter. We cleared the building from the South moving North and everyone that was located inside the building identified themselves as employees or customers who had taken shelter from the gunfire. We located a black male in the far North of the building who was directing us towards the patio portion of the business and said the shooter was outside.

We exited through the rear door where I observed a chaotic scene of multiple individuals running and screaming along with Officers Wanhala and Frazier. I observed Officer Frazier attempting to start life saving measures on a black male who was laying on his back face up in a small pool of blood who appeared to be unresponsive. I observed a black female on her knees next to Officer Frazier who was already doing chest compressions. Officer Wanhala alerted me that he located a firearm near the black male that was laying on his back face up unresponsive. I observed the weapon to be a smaller handgun with a silver slide and black grip. I instructed Officer Wanhala to clear the weapon and make it safe and secure it in his pocket for temporary safe keeping. Afterwards, I began to assess the crowd for any other obviously injured individuals. It appeared at the time that no one else in the immediate patio area was struck by gunfire. I exited the patio area to begin crowd control and clearing traffic to make a possible clear path for Emergency Medical Service (Acadian) arrival. While performing crowd control I was notified at approximately 2256 hours, by multiple individuals that a female was shot and unconscious laying on the ground on Desoto Street near a vehicle.

I was directed by a black female into the area where I observed an unidentified female laying on her right side partially under a vehicle appearing to be unconscious. I was able to pull her from under the vehicle and lay her on her back to begin examining for any injuries. I was told by another unidentified black female that the female had a Gunshot wound to her left foot. I observed what appeared to be a gunshot wound under the bottom of her foot near the pinky toe. The wound was not actively bleeding so I asked the surrounding females to help and apply pressure to the wound. I checked the female for a carotid pulse on the right side of her neck due to her being unresponsive and I was able to feel a continuous strong pulse despite the female unconscious state. After a few attempts of the sternum rub I was able to get movement from the female but still no verbal response. At this time Officer Kirkland arrived on the scene to assist me and I instructed him to take over first aid, while I transmit via emergency radio communications to dispatch her location and injury information for responding Acadian units. As I was continuing to provide crowd control, I notified dispatch to inform all responding law enforcement agencies to come to my location on Desoto Street to help with the chaotic crowd. At approximately 2308 hours officers from the Jackson County Sheriff Department and Biloxi Police Department arrived on scene to assist. I was able to break away from the crowd and inform Officer Mammoser to start creating a crime scene log. Lieutenant Kestner arrived on scene and provided crime scene tape to start creating a crime scene perimeter around the immediate area. Once the crime scene was taped off, I began providing security for the patio area to protect the integrity of the scene and possible evidence.

I spoke with a black female at approximately 0010 hours On May 6, 2023, who said she was the one giving chest compressions to the victim **Redacted**. The female was identified as **Redacted**. **Redacted** told me she also witnessed the shooting that took place on the patio. I was unable to get a statement from Ms. **Redacted** due to her leaving the scene before I could get more information from her, but I was able to get a phone number to reach her at a later. I remained on the scene for security purposes until the investigation division completed their tasks. I cleared the scene at approximately 0340 hours.

Note: I was stopped by a black male who identified himself as **Redacted** at approximately 2355 hours who said he lost his phone during the shooting. Mr. **Redacted** said he asked another officer if they could look around for him to locate it and was informed that it was found and placed onto a patrol vehicle. I looked at several vehicles but could not locate the phone initially. Later on, I spoke with Lt. Carroll and mentioned I was looking for a missing cell phone and he explained that he had found it and had placed it on top of Officer Wanhala's patrol vehicle (1712) which was at that time parked outside the crime scene. I went back and located the phone on the right side of the roof near the light bar. I placed the phone into my right pocket for safe keeping. I attempted to contact **Redacted** on his spouse cell phone number that he provided me with but didn't get an answer. I left a voicemail to inform **Redacted** that his cell phone was located and was being placed into safe keepings until he could come to claim his property. I returned to the Ocean Spring Police Department and logged the phone into the B-shift locker for safe keeping at approximately 0400 hours May 6, 2023.

On Friday, May 5th, 2023, at approximately 2250 hours, I, Officer Mammoser, along with Sgt Wallace, were conducting a traffic stop in the parking lot of the First Baptist church. During the traffic stop Sgt. Wallace and myself heard five distinct noises that sounded like gunshots from the north. Sgt. Wallace transmitted over the radio to Sgt. Meadows to confirm the suspicion. Sgt. Meadows did not respond. Sgt. Wallace and myself terminated the traffic stop and made our way to Government Street. I positioned patrol car 1302 at the intersection of Washington Avenue and Government Street.

Upon exiting the vehicle, many people were running from Government Street onto Washington Avenue. We asked where the gunshots were coming from, a passerby told us it came from The Scratch Kitchen. Sgt. Wallace and I then made our way to 1013 Government Street, The Scratch Kitchen.

Upon arriving at the front of The Scratch Kitchen, a patron of The Scratch Kitchen, stated that the shooter was inside the business. Sgt. Wallace informed dispatch of the information, and we prepared to make entry of the business. Sgt. Wallace and myself unholstered our duty weapons and made entry into the business from the front. Sgt. Wallace and myself proceeded to clear the business.

When the business was cleared, Sgt. Wallace and myself exited the business from the kitchen into the rear patio. As we broke the plane of the door, I observed chaos, everyone running and pushing each other, and screaming. I noticed one black female running, blood soaked all of her clothes. When I went to make sure she was not injured she fell on the ground. I attempted to find any wounds. She then yelled "I'm not hit.". At that time, another person grabbed me and told me there was a female that was shot outside on the east side of The Scratch Kitchen.

As I was rounding the corner I unholstered my department issued tourniquet. I found one female with a gunshot wound to her lower left leg. I notified dispatch via radio that I had one female victim on the east side of the building. I determined through my training that her wound did not require a tourniquet, instead I held pressure on the wound with a white cloth.

As I was rendering aid to the female, I heard that an officer needed assistance with crowd control in the back of The Scratch Kitchen. I then went to the back to assist with the crowd. When instructing people to get back, numerous people were screaming at us, and pushing us out of the way. They were screaming at us "Do your fucking job." I shouted "If you are not involved you have to leave." People kept pushing me trying to get back into the business. Eventually, with Jackson County deputies help, we were able to push people back and cordon off the crime scene with yellow tape.

After a crime scene perimeter was established, I retrieved a clipboard from Officer Wanhala and

On 05/05/2023 at 2251 hours, I, Officer Frazier, responded to the area of Scratch Kitchen 1013 Government St, in reference to an active shooter.

Upon arrival, I parked my patrol vehicle, on the west side of Desoto. I exited my patrol car with my service weapon out and started walking east on Desoto. As I was walking, I observed several people fleeing the area. As I walked up near the back of Scratch Kitchen, the owner, advised someone was shot on the patio part of the bar.

I observed a black male on his back with several people around him, with one female doing CPR. I walked over and cut the shirt away from the victim and observed a single gunshot wound to the lower chest, just below the right nipple and an exit wound on the left side, just below the armpit. I asked Officer Wanhala to help with crowd control. I observed the crowd continue to become more combative and started to help Officer Wanhala.

After several minutes, more officer arrived to help with the crowd. I talked with one black male who only identified himself as a deputy who observed the shooting. The Deputy advised he observed a 5'11", black male with dread locks shoot and run west. The Deputy advised he heard about 30 shots. I continued to assist with crowd control and left to check on a house who had called 911, advising someone may be hiding under the house. Officer McGill and I arrived and checked on the house and returned to the scene.

On the evening of 05-05-2023, Officer Bennett and I were working a security detail at the Walter Anderson Museum located at 510 Washington Ave. at approximately 2255 hours, Sgt. Meadows advised over the radio that a large crowd was running down Government St. and that shots were fired in the area of The Scratch Kitchen located at 1310 Government St. Sgt. Meadows then advised that there were multiple shooting victims. Sgt. Wallace advised he was on scene at The Scratch Kitchen with several shooting victims and asked for additional units.

Officer Bennett and I left The Walter Anderson Museum and responded to The Scratch Kitchen. I parked my patrol vehicle on Government St. near The Scratch Kitchen and observed a large crowd of people in the roadway and leaving the business. As I walked towards the east side of the building that leads to the patio, I observed a male with Acadian Ambulance service having trouble pulling his stretcher thorough the crowd, so I grabbed the rear of it and assisted him. As we were moving the stretcher through the crowd we observed several people arrived on scene. I assisted

On 05/05/2023 at approximately 11:00PM, I Officer John Rhodes, received a phone call from dispatch advising all units were needed at The Scratch Kitchen(1013 Government Street) in reference to a shooting. I left my residence and activated my emergency lights and siren and was able to park my patrol unit on Washington Avenue near the intersection with De Soto Street. I secured my patrol unit and walked eastbound down De Soto Street.

As I approached De Soto Street, I saw a large crowd gathered in front of The Scratch Kitchen. I was able to make contact with other Officers and we helped maintain the crime scene. While their, I made contact with Redacted who said she was flagged down by an Officer(Sgt. Meadows), and said she helped render aid to someone who had been shot on scene. I also spoke with Redacted who said she rendered aid to a female who had been shot on scene that she identified as Redacted. She said she did not have any other information about her but provided me with her mother's phone number Redacted.

I continued to maintain the perimeter, and heard Lt. Kestner call out on the radio about a possible disturbance at Neon Moon(702 Bellande Avenue). Officers Kirkland, Frazier, and I, performed an area check around the business. After discovering no signs of a disturbance, we returned to the perimeter. I saw Lt. Dye speaking to a woman who was identified as, Redacted said she had seen a black male go into Glory Bound with blood on his shirt. He said he was given a Glory Bound shirt and was inside the bar drinking. She provided a brief description of the man and gathered her information.

After standing outside the perimeter, I was told that a gun shot victim was at Merit Health 150 Reynoir Street. I went to Merit Health and made contact with the victim. After arriving I spoke with Charge Nurse Redacted. She directed me to the victim and he was identified as Redacted. Redacted had sustained a gun shot wound to his left hand. I also made contact with his girlfriend, Redacted who was sitting in the room with him.

I asked Redacted what happened. Redacted said he was in downtown Ocean Springs and he got shot. I asked him if he was at a bar. He asked Ashleigh which bar they were at. Redacted said they were at The Scratch Kitchen. I asked Ashleigh if she was there. She said she did not get out of the car. I asked Redacted if she had seen anything. She said she did not. I asked Redacted if he had been drinking tonight. Redacted admitted to drinking. I left the room and ran Redacted and Redacted information through dispatch.

I returned to the room and asked Redacted again to go over what happened. Redacted said it happened fast and he got shot in the hand. He said his sister had also gotten shot. He identified her as Redacted. I asked her where she was now. He said he did not know but that she was taken by an ambulance. After gathering all necessary information from Redacted, I asked Redacted if they had been in Ocean Springs all night.

He said he looked for his sister and called her on the phone a few times and she didn't answer. After gathering all necessary information I left the hospital.
